## Section 6 General Notes

---

### 6.1 Distributor/Redistributor License Fees

Fee applies per Distributor, Redistributor and their respective Affiliates, licensed and authorized to receive, Distribute and Use Real Time Data (pursuant to the relevant category: Level 1, Level 2 or Full Order Book), Snapshot Market Data, Delayed Data or EOD (End of Day) Data directly from NGX or each Redistributor that receives the Real Time Data, Snapshot Market Data, Delayed Data or EOD Data indirectly from any licensed Distributor.

End Users will be entitled to the prevailing discount for redistribution to clients.

### 6.2 Monthly Professional and Non-Professional (End User Fees)

End User Fee applies pursuant to the terms of the Market Data License Agreement, and as detailed below.

- a) "Professional End User" institutional End Users using the Real Time Data for trading or analytical purposes on behalf of a business or legal entity.
- b) "Non-Professional End User" is defined as:
  - i) a natural person;
  - ii) not operating a credit institution or financial services institution;
  - iii) Using the Market Data exclusively for his/her private purposes, such as, in particular, the management of his/her own private assets;
  - iv) not using the Market Data for business purposes, such as commercial securities trading or the professional management of third-party assets, or for his/her activities with a credit institution, a financial services institution or any other company which is subject to any domestic or foreign banking, stock exchange, securities trading or investment supervision;
  - v) not using the Market Data in any other manner for the purposes of third parties, such as, for instance, the non-professional management of third-party assets or within the framework of a non-commercial investment club;and
  - vi) not distributing (directly, indirectly, in whole or in part in any media or medium or in any frequency) the Market Data onward to third parties and will not make the Market Data available to any third parties.

For avoidance of doubt, Professional and Non-Professional End Users are subject to the same Fees as stated in section 1.4 above of this Pricelist.

### 6.3 Market Data Groups

Level I Market Data	Also known as Best Bid Offer (BBO) Includes Best Bid, Best Offer, Best Bid Size, and Best Offer Size, value traded per security, closing prices, all trades VWAP.
Level II Market Data	Also known as Market Depth (MD) Includes full depth of the Order book with all quotes, orders and Level 1 Market Data.

## 6.4 Tax

All Fees are exclusive of 7.5% Value Added Tax (VAT). The person/party receiving the valid VAT invoice shall, on receipt of a valid VAT invoice from the NGX pay to the NGX such additional amounts in respect of VAT as are chargeable on the supply of Market Data.

Any and all payments to the NGX do not include all applicable or future taxes (including WHT), levies, imposts, duties, fees, assessments or other charges of whatever nature imposed by any jurisdiction or any department, agency, State or other political subdivision or taxing authority.

## 6.5 Data Feed per site

Per site indicates per location of the Data Feed User. Data feed Users sometimes require Market Data Real Time Data feed for more than one location (Primary and other secondary locations around the world)

## 6.6 Internal Redistribution

Internal Redistribution refers to the redistribution by firms/ entities which receive the Market Data from a Distributor and then further distribute Market Data to one or more users/ entities within the redistributor's original network including Affiliates, if Affiliates are not considered to be clients. This Fee does not apply to End Users and their Affiliates if the License is used for the same Non-Display Usage.

The Non-Display End of Day Data Internal Redistribution Fee is applicable if the last traded price is included in the Market Data being distributed.

## 6.7 Internal Distribution

Internal Distribution refers to the distribution of NGX Market Data by authorized firms that receive NGX Market Data directly from The Exchange for the purpose of distributing such data to one or more entities within the distributor's original network including Affiliates, if Affiliates are not considered to be clients.

## 6.8 External Distribution/ Redistribution

External Distribution/Redistribution refers to distribution/redistribution by firms that distribute/redistribute the Market Data (for End of Day Data - Last traded price) externally to third-party recipients or End -Users outside their own entity. The External Distributor's/ Redistributor's Fee includes internal use of the Market Data. This License also covers Web-based products used for distributions such as websites.

## 6.9 Enterprise License

The Enterprise License grants user firms the opportunity to apply the license on an enterprise-wide basis. User firms are not expected to still pay for access Fees and User Fees when under this License. This Fee will apply on an enterprise-wide basis to firms, defined as a single entity or a group of entities within the same legal entity.

## 7.0 Indirect Access Fee

This applies to other licensed Redistributors who connect to The Exchange indirectly through another Distributor/Redistributor. It also includes Data feed recipients in each location/ site. Access Fee is charged per site per Data feed source.
